

**This newsletter provides an update for aircraft operators administered by the United Kingdom for the 2017 to 2020 period and details of the link between EU ETS and the Swiss ETS for aviation**

## **EU ETS Aviation 2017 - 2020 Scheme Years update**

On 21 June 2017 the European Council agreed to extend the existing provisions covering EU ETS aviation beyond 2016 and to prepare for the implementation of the global-market based measure as of 2021. The next stage is for the European Commission's proposal to be approved by the European Parliament. Further details can be found in the European Commission's Press Release [here](#). ## **CORSIA – the global market based measure for aviation**

The Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA) will commence in 2021. The system includes the requirement to monitor and report baseline emissions in 2019 and 2020.

The European Commission has published a proposal for amending the EU ETS Directive to implement CORSIA and an impact assessment, which can be found [here](#).

## **Linking EU ETS with the Swiss ETS**

The Swiss ETS is to be extended to cover emissions from aviation and is to be formally linked with EU ETS. The Swiss ETS will include domestic Swiss flights and flights from Switzerland to European Economic Area Member (EEA) States only, with special arrangements for flights from Basel-Mulhouse airport (LFSB). Flights from the EEA to Switzerland will remain under EU ETS.

As part of this process, the Swiss Federal Office for Environment (FOEN) is undertaking a tonne-kilometre (TKM) benchmarking exercise between 1 January and 31 December 2018.

## **Consultation on Charging Review**

The Environment Agency's charging review will shortly go out for public consultation. The review includes the amount the organisation charges for the work we carry out in relation to EU ETS for aircraft operators. We will provide a link to this consultation when this goes live.

## **Enforcement and Sanctions Guidance**

The Environment Agency is currently reviewing its guidance which sets out how the organisation makes enforcement decisions with regard to the different regimes which it regulates, including EU ETS. We will be consulting stakeholders on the revised guidance in the near future. Further information about this process will be provided shortly.

## **Do you need to update us?**

Now is a good time to check your Annual Emissions Monitoring (AEM) plan and your users on ETSWAP to make sure that the information we have is up to date. If you need to make any changes to your AEM plan you can do this through a variation to your AEM plan through the AEM Plan/Start Change Request workflow on ETSWAP.
